

**Declaration by the Account holder/s-**

- 1) Further to the Letter of Mandate executed by me/us, I/We hereby request Deutsche Bank AG, India ("Bank") to issue a Deutsche Bank Debit card ("Debit Card") to the Mandate Holder specified in the Letter of Mandate and also mentioned herein below.
- 2) I/We and the Mandate Holder acknowledge that we have read, understood and agree to abide by the terms and conditions mentioned in the General Business Conditions (a copy of which is in our possession), any special conditions relating to various services including but not limited to usage of debit card, the Letter of Mandate and such other terms and conditions as may be introduced by the Bank from time to time. I/We and the Mandate Holder accept that these terms and conditions are liable to be amended by the Bank from time to time. I/We further unconditionally and irrevocably authorize the Bank to debit my/our account annually with an amount equivalent to the fee and charges for the use of the said Debit Card, if any.
- 3) I/We confirm that the Mandate Holder shall utilize the Debit Card only for local payments and I/We and the Mandate Holder shall comply with the provisions of the Foreign Exchange Management Act, 1999 and all regulations thereof including the Exchange Control Guidelines, Foreign Exchange Management (Deposit) Regulations, 2007 etc.
- 4) I/We hereby undertake that I/We made known to the Mandate Holder the permissible uses of the Debit Card as per extant regulations, guidelines and Bank rules/guidelines in this regard.
- 5) I/We hereby confirm and declare that the Bank shall have no liability or responsibility to verify the permissibility, genuineness and/or accuracy of the transaction or to undertake any verification or checks prior to authorizing any transaction made by the Mandate Holder on the Debit Card.
- 6) I/We hereby undertake to indemnify the Bank against any loss, damage, claim, action, proceedings, cost, charges and expenses that may be suffered or incurred by it on account of any activity undertaken by the Mandate Holder by the use/non use of the Debit Card.
- 7) The Bank shall make best efforts to cancel the Debit Card within three (3) business days of written request for cancellation received by the Bank. However, the Bank shall not be liable or responsible for any loss, damage or injury caused on account of any delay in cancellation of the Debit Card. I/We acknowledge that I/We shall be responsible for all risk and consequences arising from use of the Debit Card till the same is cancelled. I/We hereby undertake to have the Debit Card in my / our possession, prior to requesting the Bank for cancellation.
- 8) The Bank reserves the right to cancel/suspend/terminate the Debit Card at any time on account of any reason as determined by the Bank in its sole discretion. I/We understand that reactivation of the Debit Card (either on my/our request or by the Bank) may be considered by the Bank only after receipt of written request by the Bank from me/us.
